Legislative Update: What To Expect Nationally and in Nevada in 2023

Well known, Nevada State Legislature analyst and lobbyist, Jim Wadhams, will speak at a special Northern Nevada Association of Health Underwriters, legislative presentation on January 11th.

Wadhams is considered one of the state's leading experts on governmental affairs, insurance law and administrative law as it relates to legislation and regulation related to the healthcare and life insurance industry.

Wadhams will provide an update on legislation likely to be introduced in this year's upcoming legislative session. He will also review recently passed national healthcare legislation and possible new federal regulation in the new congress.

New Nevada State By-Laws

The National Association of Health Underwriters has changed its name to the "National Association of Benefits and Insurance Professionals".

Nevada chapters will need to change their names to conform to the new national name.

Locally, our chapter will become the "National Association of Benefits and Insurance Professionals – Northern Nevada".

Likewise, the Nevada State chapter's name will change to the "National Association of Benefits and Insurance Professionals – Nevada".

Both local and state chapters will write a series of amendments to their existing By-Laws and file those new By-Laws with the Secretary of State.

NNAHU will vote on the state's changes first.

You are invited to review the proposed changes for the State By-Laws and to vote on them on February 8th at the Northern Nevada Monthly Membership meeting and luncheon.

The vote will take place in person during the first fifteen minutes of the meeting.
